



# Town of Philipstown Community Choice Aggregation (CCA) Announcement

Dear Philipstown Resident,

I'm pleased to announce the launch of Hudson Valley Community Power in Philipstown, a new Community Choice Aggregation (CCA) program<sup>1</sup> that allows us to pool local electricity demand with other Hudson Valley municipalities. Through this program, we can leverage the collective buying power of our homes and small businesses to negotiate energy supply rates, designate preferred generation sources, and select an Energy Services Company as the default electricity supplier to our community.

While Central Hudson will continue to deliver the electricity, provide repair services, and handle billing, the utility will no longer be the default supplier of electricity to our community. After a competitive procurement process, we have selected Direct Energy as our community's default supplier. As of July 1, 2019, the default energy supply in Philipstown will now be 100% renewable, sourced from New York State clean energy facilities.

## Hudson Valley Community Power (HVCP)

**PRICE STABILITY:** Program participants will pay a fixed rate for electricity.<sup>2</sup> Fixed rates will take effect on July 1, 2019 and will not increase for a period of 24 months.

**PARTICIPATION<sup>3</sup>:** All eligible residents and small commercial electricity customers will be automatically enrolled. You do not need to take any action to enroll. Should you not wish to participate, you may opt-out of the program by **June 20**. Those who opt-out will continue to receive electricity supply from Central Hudson. After program launch, customers may cancel service at any time without incurring cancellation fees or penalties.

**STANDARD OPTION:** If you wish to participate in the program, but don't want 100% renewable energy by default, you may still enroll in a fixed rate by choosing Standard Supply. <sup>2</sup> There is no guarantee that the HVCP fixed rate will be lower than the monthly variable Central Hudson rate in any given month, or over the life of the program.

<sup>3</sup> Assistance Program Participants (APPs), time of use customers, and those who have selected an alternate supplier will not be automatically enrolled.

<sup>4</sup> Average weighted monthly variable Central Hudson supply rate for previous 12 months, April 2018-March 2019.

## HOW TO OPT-OUT

If you do not wish to participate in the program, you may opt-out via mail, phone, or online, as follows:

*Opt-out by mail:* Fill out the prepaid opt-out card and return in the enclosed envelope.

*Opt-out by phone:* Call us at 845-859-9099.
